TRADE MARK ASSIGNMENT AGREEMENT

Between

LUVANIS S.A.

-and-

M.F.T.G. INTERNATIONAL LTD.

THIS AGREEMENT is dated June 10, 2011.

PARTIES:

1. LUVANIS S.A., a company incorporated under the laws of Luxembourg under number B144993 and whose registered office is at 4, rue Dicks, L-1417 Luxembourg ("the Assignor"); and
2. MF T.G. INTERNATIONAL LTD a company incorporated under the laws of England under number 07659405 and whose registered office is at Skelton House, New Road, Old Snydale, West Yorkshire, England, WF76EZ, UK.

WHEREAS:

1. The Assignor is the proprietor of the trade mark applications and registrations listed in the schedule hereto ("the Trade Marks").
2. The Assignor has agreed to assign all its rights in and to the Trade Marks to the Assignee on the terms set out below.

AGREED TERMS:

1. Assignment

In consideration of the sum of One British Pound (£1) paid by the Assignee to the Assignor (receipt of which is hereby acknowledged) and for all other good and valuable consideration, the Assignor hereby assigns with full title guarantee to the Assignee absolutely its ownership of the Trade Marks and all and any rights in and to the Trade Marks. Any common law rights and all the goodwill attaching to the Trade Marks shall also pass to the Assignee.

2. Proceedings

This assignment shall include the right for the Assignee to bring proceedings against any third party in respect of the Trade Marks (including proceedings against any third party for infringement of the Trade Marks or for passing-off or for otherwise infringing the rights of the Assignor in the Trade Marks).

The Assignor agrees and undertakes to provide the Assignee (at its request) with all such assistance with any proceedings which may be brought by or against the Assignee against or by any third party in relation to the Trade Marks.

3. Further assurance

The Assignor covenants that, at the cost of the Assignee and at any time and from time to time, it shall execute such deeds or documents and do such acts or things as may be necessary or desirable to give effect to this assignment.

4. Governing law and jurisdiction


This assignment shall be governed by and construed in accordance with the laws of England and Wales and the parties submit to the exclusive jurisdiction of the English Courts.
