**FIRST ADDENDUM CORRECTING PARTY NAME
TO
ASSIGNMENT
AND TO
AGREEMENT TO ASSIGN TRADEMARK**

THIS FIRST ADDENDUM is dated as of June 21, 2011 and is by and between JOHN HOWIESON and DIANE B. HOWIESON (hereinafter collectively "the Howiesons") and SADDLEBACK FARM, WINERY, VINEYARDS AND STABLES, LLC (hereinafter "Saddleback").

Background Statements:

A. The parties entered into that certain Agreement to Assign Trademark dated as of April 4, 2001 whereby the Howiesons agreed to sell and transfer to Saddleback all right, title and interest of the Howiesons in and to the trademark VERITAS, U.S. Trademark Registration No. 1,006,979 for such mark, and the good will associated therewith, a true and correct copy of which Agreement is attached hereto as Exhibit 1 (hereinafter the "Agreement").

B. Pursuant to the Agreement, the Howiesons executed and delivered to Saddleback that certain trademark Assignment dated as of April 4, 2001, a true and correct copy of which is attached hereto as Exhibit 2 (hereinafter the "Assignment").

C. The Assignment was thereafter duly recorded in the United States Patent and Trademark Office by former counsel for Saddleback.

D. Saddleback only recently discovered that due to clerical errors in the Agreement and the Assignment, Saddleback is erroneously identified therein as "Saddleback Farm Winery, Vineyard and Stables, LLC" instead of its actual legal name "Saddleback Farm, Winery, Vineyards and Stables, LLC" as chartered in the Commonwealth of Virginia effective December 27, 1999.

E. The parties now wish by this FIRST ADDENDUM to memorialize and correct the said clerical errors in the Agreement and the Assignment.

Statement of Agreement:

NOW THEREFORE, in consideration of the premises and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. The Agreement is hereby modified and amended to cause Saddleback's name to correctly read Saddleback Farm, Winery, Vineyards and Stables, LLC.

2. The Assignment is hereby modified and amended to cause Saddleback's name to correctly read Saddleback Farm, Winery, Vineyards and Stables, LLC.

3. Except to the extent expressly stated in Paragraphs 1 and 2 herein, the Agreement and the Assignment remain unchanged and in full force and effect according to their respective original terms after signature of this FIRST ADDENDUM by the parties, and the parties hereby ratify and affirm the same as their respective lawful and binding acts, as so amended by this FIRST ADDENDUM.

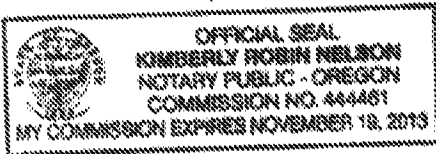

Assignee shall have no claim against Assignors in the event that this Agreement and the Assignment are not legally recognized as transferring U.S. Trademark Registration No. 1,006,979 to Assignee.

4. In the event of an actual or alleged conflict between the Assignment and this Agreement, the terms of this Agreement shall control.

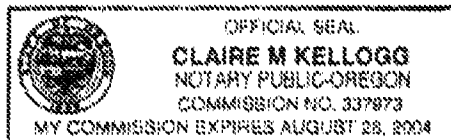

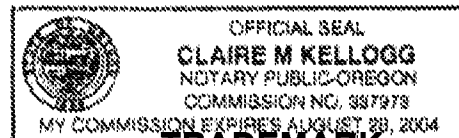
