## TRADEMARK ASSIGNMENT

This Trademark Assignment (the "Trademark Assignment") is effective as of this 21<sup>st</sup> day of March, 2011, and provided by Turner Broadcasting System, Inc., a corporation organized and existing under the laws of the State of Georgia with offices located at One CNN Center, Atlanta, Georgia 30303-2762 ("Assignor"), to BUZZMEDIA, a corporation organized and existing under the laws of the State of California with offices located at 6464 Sunset Boulevard, Suite 650, Los Angeles, CA 90028 (hereinafter "Assignee").

WHEREAS, Assignor and Assignee are parties to that certain Asset Purchase Agreement, dated as of February 4, 2011 (the "APA"), pursuant to which Assignor has agreed to sell, and Assignee has agreed to purchase, the Purchased Assets, which include the trademarks identified in Appendix A hereto (the "Marks"), which is incorporated herein by reference;

WHEREAS, Assignor is the owner of the Marks; and

WHEREAS, the execution and delivery of this Trademark Assignment is a condition precedent to the consummation of the transactions contemplated by the APA.

NOW THEREFORE, in consideration of the premises and mutual agreements hereinafter set forth, Assignor and Assignee hereto agrees as follows:

1. Sale and Transfer of Marks. For good and valuable consideration, adequacy and legal sufficiency of which are hereby acknowledged, and as contemplated in Section 1.1 of the APA, Assignor hereby sells, transfers, assigns, conveys, grants and delivers to Assignee all of Assignor's rights, title and interest in and to the Marks, including any and all applications(s) for registration and registration(s), together with the goodwill appurtenant thereto symbolized by the Marks.

2. Further Actions. Assignor covenants and agrees to assist Assignee in the defense of the sale, transfer, assignment, conveyance, grant and delivery of the Marks hereby made against all persons whomsoever, and, at the request of Assignee, to execute and deliver further instruments of transfer and assignment and take such other action as Assignee may reasonably request to more effectively transfer and assign to, and vest in, Assignee each of the Marks.

3. Terms of the APA. The terms of the APA are incorporated herein by reference. In the event of any conflict or inconsistency between the terms of the APA and the terms hereof, the terms of the APA shall govern.
