DISCHARGE OF SECURITY INTEREST IN TRADEMARKS

This Discharge of the Security Interest in Trademarks is given this 7th day of July, 2011 by by WELLS FARGO BANK, NATIONAL ASSOCIATION (successor to Wells Fargo Business Credit, Inc., the "Lender"), to INOLEX CHEMICAL COMPANY, a corporation organized under the laws of the Commonwealth of Pennsylvania, and INOLEX INVESTMENT CORP., a corporation organized under the laws of the State of Delaware (collectively and individually, the "Grantor").

WITNESSETH:

WHEREAS, the obligations secured by the Security Agreement have been paid in full or otherwise satisfied and Grantor has requested that Secured Party terminate and release its security interest in the Trademarks.

WHEREAS, Lender has agreed to terminate and release its security interest in the Trademarks.

NOW THEREFORE, for and in consideration of the foregoing and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Lender hereby declares that the security interest granted by Grantor to Lender in and to the Trademarks is hereby discharged, released and terminated and the recording officer in the U.S. Patent and Trademark Office, is hereby authorized to cancel the Security Agreement of record.


