TRADEMARK SECURITY INTEREST AGREEMENT

Borrower expressly acknowledges and affirms that the rights and remedies of Investor with respect to the security interest granted hereby are more fully set forth in the Agreements.





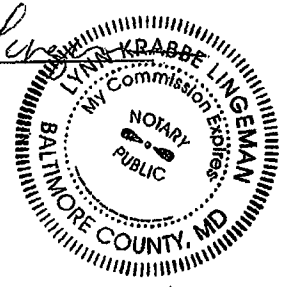
