**RELEASE OF TRADEMARK SECURITY INTEREST
IN EXCLUSIVELY LICENSED TRADEMARKS**

THIS RELEASE OF TRADEMARK SECURITY INTEREST IN EXCLUSIVELY LICENSED TRADEMARKS is made effective as of June 17, 2011, by and from JPMORGAN CHASE BANK, N.A., for itself and as Administrative Agent for the Secured Parties (the "Administrative Agent") to ENDO PHARMACEUTICALS INC., a Delaware corporation (the "Grantor"), as follows:

NOW THEREFORE, the Administrative Agent hereby releases the security interest in all of the Grantor's right, title and interest in and to the trademark registrations and trademark applications under and to the extent set forth in and permitted by the exclusive license to Grantor of such trademark registrations and trademark applications listed on the attached Schedule A, and retransfers and reassigns any and all right, title and interest it may have in and to the Marks without recourse to the Grantor.
