TERMINATION OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION OF SECURITY INTEREST IN TRADEMARKS**, dated as of July __, 2011, is made by Fortress Value Recovery Fund I LLC, formerly known as D.B. Zwirn Special Opportunities Fund, L.P., a Delaware limited liability company, in its capacity as administrative agent for the Lenders (the "Administrative Agent").

WHEREAS, (i) MATTEC CORPORATION, an Ohio corporation ("Mattec") has granted a security interest in certain personal property to the Administrative Agent, including without limitation a security interest in certain trademarks and trademark applications ("Trademarks"), pursuant to that certain Trademark Security Agreement dated as of January 23, 2008, (ii) CMS MANUFACTURING SYSTEMS, INC., a Tennessee corporation ("CMS TN"), has granted a security interest in certain personal property to the Administrative Agent, including without limitation a security interest in certain Trademarks, pursuant to that certain Trademark Security Agreement dated as of January 23, 2008, (iii) CMS SOFTWARE CANADA, INC., a Canadian corporation ("CMS Canada"), has granted a security interest in certain personal property to the Administrative Agent, including without limitation a security interest in certain Trademarks, pursuant to that certain Trademark Security Agreement dated as of September 11, 2008 and (iv) INFORMANCE INTERNATIONAL, INC., a Delaware corporation ("Informance" and together with Mattec, CMS TN and CMS Canada, collectively, the "Grantors" and each individually, the "Grantor") has granted a security interest in certain personal property to the Administrative Agent, including without limitation a security interest in certain Trademarks, pursuant to that certain Trademark Security Agreement dated as of March 23, 2010; and

WHEREAS, the security interests granted to the Administrative Agent were recorded at the United States Patent and Trademark Office as follows: on January 30, 2008 at Reel 3707 and Frame 0074; January 30, 2008 at Reel 3707 and Frame 0083, on September 16, 2008 at Reel 3853 and Frame 0592 and on March 26, 2010 at Reel 4174 and Frame 0916; and

WHEREAS, the Administrative Agent has agreed to terminate and release its security interest in all of such Trademarks, including, without limitation, the Trademarks identified on Schedule A attached hereto.

NOW, THEREFORE, for valuable consideration, the Administrative Agent hereby terminates and releases all mortgages, liens, and security interests granted to the Administrative Agent in the following:

1. all of the Grantors' Trademarks including those referred to on Schedule A attached hereto;
2. all goodwill of the business connected with the use of, and symbolized by, each Trademark; and
3. all products and proceeds of the foregoing, including, without limitation, any claim by any Grantor against third parties for past, present or future (i) infringement or

dilution of any Trademark or (ii) injury to the goodwill associated with any Trademark.
