RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this "Release") is made as of July 14, 2011 ("Effective Date") by and between Silicon Valley Bank, a California bank, with its principal office at 3003 Tasman Drive, Santa Clara, California 95054 ("Grantee"), and Closedloop Solutions, Inc., a Delaware corporation, with its principal office at 1001 Marshall Street, Suite 500, Redwood City, CA 94063-2000 ("Grantor").



NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby grants, assigns and conveys, without representation, recourse or warranty whatsoever, back to Grantor all of Grantee's rights, title and interest in the Intellectual Property Collateral, if any, and terminates the Security Agreement, and hereby terminates, cancels and releases any and all security interests it has against the Intellectual Property Collateral.
