AGREEMENT

Pursuant to California Corporations Code Section 17555, WebMediaBrands Inc., a Delaware corporation and the surviving corporation (the "Surviving Entity"), hereby agrees as follows:

- (3) The Surviving Entity will promptly pay the holder of any dissenting interest in the Disappearing Entity the amount to which that person is entitled under California law.
