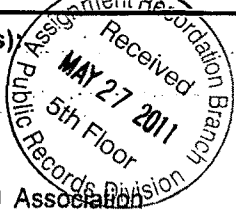




SETTLEMENT AGREEMENT
