## **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS ("Termination") is executed and delivered as of the 3rd day of October, 2005 by Wells Fargo Bank, National Association, as Administrative Agent ("Lender"), to Argosy Gaming Company, an Illinois corporation ("Argosy Gaming"), The Missouri Gaming Company, a Missouri corporation, Alton Gaming Company, an Illinois corporation ("Alton Gaming"), Iowa Gaming Company, an Iowa company, Jazz Enterprises, Inc., a Louisiana corporation, Argosy of Louisiana, Inc., a Louisiana corporation, Catfish Queen Partnership in Commendam, a Louisiana partnership in commendam ("Catfish Queen"), The Indiana Gaming Company, an Indiana company, Argosy of Iowa, an Iowa corporation, Belle of Sioux City, L.P., an Iowa limited partnership ("Belle of Sioux City"), Indiana Gaming Holding Company, an Indiana corporation, Indiana Gaming, II, L.P., an Indiana limited partnership, Centroplex Center Convention Hotel, L.L.C., a Louisiana limited liability company, Indiana Gaming Company, L.P., an Indiana limited partnership and Empress Casino Joliet Corporation, an Illinois corporation ("Empress") (Argosy Gaming, Alton Gaming, Catfish Queen, Belle of Sioux City and Empress together with each of the other parties, other than Lender, are referred to as the "Assigning Parties").

### **BACKGROUND**

A. Argosy Gaming granted a security interest in certain trademarks to Lender on: (i) June 8, 1999, which was recorded with the U.S. Patent and Trademark Office ("PTO") at Reel/Frame 1921/0896 as set forth on Exhibit A hereto; (ii) March 2, 2001, which was recorded with the PTO at Reel/Frame 2299/0062 as set forth on Exhibit B hereto; and (iii) July 31, 2001, which was recorded with the PTO at Reel/Frame 2412/0001 as set forth on Exhibit C hereto.

B. Alton Gaming granted a security interest in certain trademarks to Lender on: (i) June 8, 1999, which was recorded with the PTO at Reel/Frame 1922/0504 as set forth on Exhibit D hereto; (ii) March 2, 2001, which was recorded with the PTO at Reel/Frame 2298/0624 as set forth on Exhibit E hereto; and (iii) July 31, 2001, which was recorded with the PTO at Reel/Frame 2411/0685 as set forth on Exhibit F hereto.

C. Catfish Queen granted a security interest in certain trademarks to Lender on: (i) On June 8, 1999, which was recorded with the PTO at Reel/Frame 1922/0149 as set forth on Exhibit G hereto; (ii) March 2, 2001, which was recorded with the PTO at Reel/Frame 2298/0831 as set forth on Exhibit H hereto; and (iii) July 31, 2001, which was recorded with the PTO at Reel/Frame 2482/0859 as set forth on Exhibit I hereto.

D. Empress granted a security interest in certain trademarks to Lender on: (i) June 30, 1998, which was recorded with the PTO at Reel/Frame 1759/0152 as set forth on Exhibit J hereto; and (ii) July 31, 2001, which was recorded with the PTO at Reel/Frame 2411/0633 as set forth on Exhibit K hereto.

E. Belle of Sioux City, granted a security interest in certain trademarks to Lender on: June 8, 1999, which was recorded with the PTO at Reel/Frame 1922/0074 as set forth on Exhibit L hereto; (ii) March 2, 2001, which was recorded with the PTO at Reel/Frame 2300/0581 as set forth on Exhibit N hereto; and (iii) July 31, 2001, which was recorded with the PTO at Reel/Frame 2411/0944 as set forth on Exhibit O hereto.

F. On September 30, 2004, each of the Assigning Parties executed and delivered to Lender a certain Amended and Restated Pledge and Security Agreement ("Pledge and Security Agreement") and

granted to Lender a security interest in certain trademarks which was recorded with the PTO at Reel/Frame 2958/0001 as set forth on the Exhibit O hereto.

G. The Assigning Parties, or certain of the Assigning Parties, granted Lender a security interest in certain state trademark registrations, including those registrations listed on Exhibit P hereto

NOW, THEREFORE, with the foregoing Background incorporated by reference and intending to be legally bound hereby, the parties agree as follows:

1. Lender terminates all of the security interests granted by each and all of the Assigning Parties and releases all of its rights, titles and interests in the trademarks set forth on the Exhibits attached hereto.

2. Each Assigning Party, or its designee, may record this Termination in the USPTO and in any other trademark offices as may necessary to carry out the intentions of this Termination.

3. The Lender agrees to execute and deliver such other documents as may be reasonably requested and prepared to carry out the intentions of this Termination.
