

ASSIGNOR represents and warrants that it will not use, seek to register, register or authorize others to use, seek to register or register the Mark or Registration or any other mark comprising or containing the word "MOSQUITO." ASSIGNOR represents and warrants that, to the best of ASSIGNOR'S knowledge, there is no claim or potential claim of any third party with respect to any ownership interest, claim of infringement, likelihood of confusion or unfair competition relating to the Mark or Registration.
