RELEASE OF SECURITY INTEREST

This Release of Security Interest ("Release") is made by Wells Fargo Bank, National Association (as successor to Wachovia Bank, National Association), having a principal place of business at 201 Main Street, Suite 300, Fort Worth, Texas 76102, as Administrative Agent ("Secured Party") in favor of Avomex, Inc., a Texas corporation with an address at 300 Burlington Road, Saginaw, Texas 76179 ("Grantor").

RECITALS

WHEREAS, Secured Party and Grantor previously entered into a Trademark Security Agreement ("Agreement"), dated as of December 15, 2009, a copy of which was recorded with the United States Patent and Trademark Office on December 28, 2009, at Reel 4125, Frame 0229.

WHEREAS, pursuant to the Agreement, Secured Party owns a security interest in Grantor's Trademarks (as defined in the Agreement), including but not limited to those U.S. Trademark and/or Service Mark Applications and Registrations that are listed in Exhibit A of the Agreement, and reproduced for clarification purposes in the document attached hereto as Exhibit 1.

WHEREAS, Secured Party now wishes to terminate its security interest in, and release its liens in, all of Grantor's Trademarks on the terms and conditions set forth herein.

NOW, THEREFORE, subject to the terms, conditions, covenants and provisions of this Release, and for other good and valuable consideration, the receipt and legal sufficiency of which are hereby acknowledged, the Secured Party, intending to be legally bound, agrees as follows:

TERMINATION AND RELEASE

Effective as of September 2, 2010, Secured Party hereby releases, discharges and terminates all liens, security interests, assignments, and other interests of Secured Party in all of Grantor's Trademarks, including, without limitation, its trademarks, service marks, and trademark and service mark applications and registrations listed in Exhibit 1, which is attached hereto and incorporated herein by reference, the debt secured or otherwise held thereby having been paid and satisfied in full.

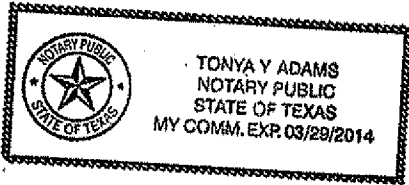
