ACKNOWLEDGMENT OF SECURITY INTEREST IN TRADEMARKS

July 6, 2011

WHEREAS, DEVCON SECURITY HOLDINGS, INC. (f/k/a Devcon Security Services Corp.), a Florida corporation ("Holdings"), DEVCON SECURITY SERVICES CORP. (f/k/a Security Equipment Company, Inc.), a Delaware corporation ("Services") and MUTUAL CENTRAL ALARM SERVICES INC., a New York corporation ("Mutual" and together with Holdings and Services, individually and collectively, "Grantor") has adopted, used and is using, and holds all right, title and interest in and to, the trademarks and service marks listed on the annexed Schedule 1, which trademarks and service marks are registered or applied for in the United States Patent and Trademark Office (the "**Trademarks**");

WHEREAS, Grantor has entered into a Security Agreement dated as of November 10, 2005, by and among Grantor, Agent (as defined below) and certain of the Loan Parties (as defined in the Credit Agreement (as defined below), as amended by the First Amendment to Security Agreement dated as of September 30, 2009 among certain of the Loan Parties and the Agent, by the Assumption and Supplemental Credit Agreement and Loan Documents dated as of April 12, 2011 among the Loan Parties and the Agent and by that certain Omnibus Amendment Agreement and Reaffirmation dated as of July 6, 2011, by the Loan Parties in favor of Agent (as so amended and amended, restated, supplemented or otherwise modified from time to time in accordance with its terms, the "**Security Agreement**"), in favor of CapitalSource Finance LLC, as agent (the "**Agent**") for the lenders (the "**Lenders**") from time to time party to that certain Second Amended and Restated Credit Agreement, dated as of July 6, 2011, by and among Agent, the Lenders and the Loan Parties (the "**Credit Agreement**");

WHEREAS, pursuant to the Security Agreement, Grantor has granted to Agent on behalf of Lenders a continuing security interest in all right, title and interest of Grantor in, to and under the Trademarks, together with, among other things, the good-will of the business symbolized by the Trademarks and the applications and registrations thereof, and all proceeds thereof, including any and all causes of action which may exist by reason of infringement thereof and any and all damages arising from past, present and future violations thereof (the "**Collateral**"), to secure the payment, performance and observance of the Secured Obligations (as defined in the Security Agreement);

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantor does hereby grant to Agent on behalf of the Lenders a continuing security interest in the Collateral to secure the prompt payment, performance and observance of the Secured Obligations.

Grantor does hereby further acknowledge and affirm that the rights and remedies of the Agent on behalf of the Lenders with respect to the Collateral are more fully set forth in the Security Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein.


