## RELEASE OF SECURITY INTEREST

This **RELEASE OF SECURITY INTEREST**, dated as of November 21, 2003, is made by BANK OF AMERICA, N.A. ("BOA").

**WHEREAS**, Pro Mach, Inc. ("Pro Mach") entered into a certain AMENDED AND RESTATED TRADEMARK AND LICENSE SECURITY AGREEMENT with Wexxar Packaging Inc. ("Wexxar") dated February 27, 2003 (the "Trademark Security Agreement"), pursuant to which Pro Mach obtained a security interest in certain Trademarks and Licenses as those terms are defined in the Trademark Security Agreement, including those trademarks identified in Schedule A; and

**WHEREAS**, Pro Mach and LaSalle Bank National Association ("LBNA" – predecessor to BOA) entered into a certain ASSIGNMENT OF TRADEMARKS dated February 27, 2003 (the "Assignment"), pursuant to which Pro Mach assigned its rights under the Trademark Security Agreement to LBNA; and

**WHEREAS**, Wexxar Packaging Machinery Ltd. (predecessor to Wexxar) entered into a certain WEXXAR PACKAGING MACHINERY LTD. SECURITY AGREEMENT (the "WPM Security Agreement") with LaSalle National Bank (predecessor to the LBNA) dated December 21, 1998, pursuant to which LaSalle National Bank received a security interest in certain Collateral (as defined in the WPM Security Agreement), including Reg. No. 1,404,636 listed in Schedule A;

**WHEREAS**, LBNA subsequently became part of BOA;


**WHEREAS**, BOA has agreed to terminate and release the security interest in the Trademarks and Licenses and Collateral, including, without limitation, the Trademarks identified on Schedule A attached hereto.

**NOW, THEREFORE**, for valuable consideration, BOA hereby terminates and releases all mortgages, liens, and security interests granted (pursuant to the Trademark Security Agreement, Assignment and the WPM Security Agreement) to BOA or its predecessors in the following:

1. the Trademarks as defined in the Trademark Security Agreement, including the trademarks identified in Schedule A attached hereto;
2. the goodwill of the business connected with and symbolized by the Trademarks;
3. the Licenses covered by the Trademark Security Agreement; and
4. the Collateral covered by the WPM Security Agreement.
