TRADEMARK ASSIGNMENT

This TRADEMARK ASSIGNMENT (this "Assignment"), effective the 28th day of June, 2011 is made and entered into by and between STi Prepaid, LLC, a Delaware limited liability company ("STi"), Epana Networks, Inc., a Delaware corporation ("Epana"), Kare Distribution, Inc., a Delaware corporation ("Kare"), all having a place of business at 1250 Broadway 26th Floor, New York, NY 10001 (STi, Epana and Kare collectively referred to as "Assignors"), and TNW Corporation, a Delaware corporation having a place of business at 1250 Broadway 26th Floor, New York, NY 10001 ("Assignee") (each a "Party," and collectively, the "Parties").

WHEREAS, Assignors are the owner of the trademarks, trademark registrations, and trademark applications set forth on Schedule A hereto (the "Trademarks");

WHEREAS, Assignors and Assignee are parties to that certain Assignment and Assumption Agreement dated June 28, 2011 (capitalized terms used herein but not otherwise defined herein shall have the meanings set forth in the Purchase Agreement);

WHEREAS, pursuant to the Assignment and Assumption Agreement, Assignors agreed to transfer, *inter alia*, all of Assignors' respective rights, titles and interests in and to the Trademarks and the goodwill of the business symbolized by the Trademarks; and

WHEREAS, the execution and delivery of this Assignment is a condition to Closing.

NOW THEREFORE, for the consideration set forth in the Purchase Agreement, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:

1. Assignment. Effective upon the Closing, Assignors hereby assigns to Assignee all of Assignors' right, title and interest in and to the Trademarks and any and all goodwill of the business symbolized by the Trademarks, including all rights therein provided by international conventions and treaties, and the right to sue for past, present and future infringement thereof.
2. No Warranties. Except as expressly provided in the Purchase Agreement, Assignors makes no warranties, express or implied, with respect to the Trademarks.
3. Further Assurances. Assignors shall, at the cost and expense of Assignee, take all actions and execute all documents necessary or desirable to record and perfect the interest of Assignee in and to the Trademarks, and shall not enter into any agreement in conflict with this Assignment.
