## PATENT AND TRADEMARK SECURITY AGREEMENT

This Patent and Trademark Security Agreement (this "Agreement") is entered into as of June 21, 2011 by and between Human Touch, LLC, a Delaware limited liability company (the "Grantor"), in favor of The Huntington National Bank, a national banking association (the "Lender"), pursuant to the Credit Agreement referred to below.

### Recitals

A. The Grantor and the Lender have entered into a Credit Agreement dated as of the date hereof (as amended, supplemented, restated or otherwise modified from time to time, including any agreement entered into in replacement thereof, the "Credit Agreement"), pursuant to which the Lender has agreed, subject to certain terms and conditions, to extend credit and make certain other financial accommodations available to the Grantor.

B. In connection with the Credit Agreement, the Grantor, certain affiliates of the Grantor and the Lender entered into a Security Agreement dated as of the date hereof (as amended, supplemented, restated or otherwise modified from time to time, including any agreement entered into in replacement thereof, the "Security Agreement"), pursuant to which the Grantor has granted to the Lender a security interest in the Grantor's assets to secure all present and future Indebtedness (as such term is defined in the Credit Agreement and the Security Agreement).

C. Pursuant to the terms of the Security Agreement, the Grantor has pledged, assigned and granted to the Lender a security interest in, among other assets, all patents and patent applications and all trademarks and trademark applications of the Grantor.

### Agreement

In consideration of the recitals set forth above and the mutual agreements contained herein and in the Credit Agreement and the other Loan Documents, the Grantor hereby grants to the Lender, to secure the Indebtedness, a continuing security interest in all of the Grantor's right, title and interest in, to and under the following, whether now owned by or owing to, or hereafter acquired by or arising in favor of the Grantor (including as identified by any trade name or any derivations thereof):

- (1) each unregistered patent, patent registration and patent application, including, without limitation, each patent and patent application referred to in Schedule 1 attached hereto, together with any renewal thereof;
- (2) each patent license to which the Grantor is a party, including, without limitation, each patent license listed on Schedule 1 attached hereto;
- (3) all products and proceeds of the foregoing, including, without limitation, any and all claims by the Grantor against third parties for past, present or future infringement of any patent, including, without limitation, any patent referred to in Schedule 1 attached hereto, any patent issued pursuant to a patent application

referred to in Schedule 1 attached hereto and any patent licensed under any patent license listed on Schedule 1 attached hereto (items 1 through 3 being herein collectively referred to as the "Patent Collateral");

- (4) each unregistered trademark, trademark registration and trademark application, including, without limitation, each trademark and trademark application referred to in Schedule 2 attached hereto, together with any renewal thereof;
- (5) each trademark license to which the Grantor is a party, including, without limitation, each trademark license listed on Schedule 2 attached hereto;
- (6) all products and proceeds of the foregoing, including, without limitation, any and all claims by the Grantor against third parties for past, present or future infringement of any trademark, including, without limitation, any trademark referred to in Schedule 2 attached hereto, any trademark issued pursuant to a trademark application referred to in Schedule 2 attached hereto and any trademark licensed under any trademark license listed on Schedule 2 attached hereto (items 4 through 6 being herein collectively referred to as the "Trademark Collateral");

The security interest granted to the Lender herein is granted in furtherance, and not in limitation of, the security interests granted to the Lender pursuant to the Security Agreement and nothing in this Agreement shall limit or otherwise modify the security interests granted in the Security Agreement. The Grantor acknowledges and affirms that the rights and remedies of the Lender with respect to the security interest in the Patent Collateral and the Trademark Collateral made and granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated herein by reference as if fully set forth herein. In the event of any conflict between the terms of this Agreement and the Security Agreement, the terms of the Security Agreement shall govern. This Agreement may be executed in any number of counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument. All capitalized terms used but not defined herein shall have the respective meanings ascribed thereto in the Security Agreement.

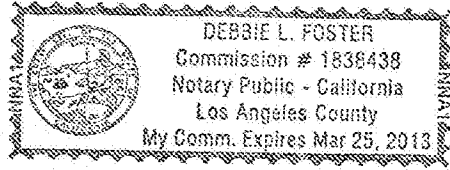

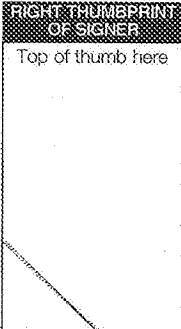
