**ARTICLES OF MERGER
OF
ZYLERA PHARMACEUTICALS, LLC
WITH AND INTO
PALMER SQUARE PHARMA, LLC**

Pursuant to North Carolina General Statutes Section 57C-9A-22, Palmer Square Pharma, LLC hereby submits these Articles of Merger for the purpose of merging Zylera Pharmaceuticals, LLC with and into Palmer Square Pharma, LLC.

I. The merging entities are Palmer Square Pharma, LLC, a limited liability company organized under the laws of the State of North Carolina, and Zylera Pharmaceuticals, LLC, a limited liability company organized under the laws of the State of North Carolina.

II. The name of the surviving entity is Palmer Square Pharma, LLC.

III. The Articles of Organization of the surviving entity are amended as follows: Section 1 is deleted in its entirety and replaced with the following:

“1. The name of the limited liability company is Zylera Pharmaceuticals, LLC.”

Section 7 is deleted in its entirety and replaced with the following:

“7. Principal office information:

a. The limited liability company has a principal office. The street and mailing address and county of the principal office of the limited liability company is: 2530 Meridian Parkway, Suite 300, Durham, Durham County, NC 27713.”

IV. The Plan of Merger was duly approved by each of Palmer Square Pharma, LLC and Zylera Pharmaceuticals, LLC in the manner prescribed by law.

V. This merger shall become effective at 12:01 a.m. on July 1, 2011.
