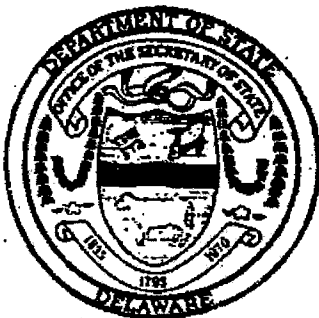

FIRST: That the Board of Directors of said corporation, at a meeting held June 21, 1983 at which a quorum was present, adopted a resolution proposing and declaring advisable the following amendment to the Certificate of Incorporation of said corporation:

RESOLVED, that this Board of Directors hereby declares it advisable that the Certificate of Incorporation of the Company be amended by changing Article FIRST thereof to read in its entirety as follows:

"FIRST: The name of the Corporation is Ericsson, Inc."

SECOND: That in lieu of a meeting and vote of stockholders, the stockholders have given unanimous written consent to said amendment in accordance with the provisions of section 228 of the General Corporation Law of the State of Delaware.

THIRD: That the aforesaid amendment was duly adopted in accordance with the applicable provisions of sections 242 and 228 of the General Corporation Law of the State of Delaware.
