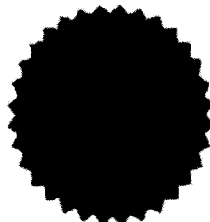

SolArc, Inc., a corporation organized and existing under the laws of the State of Oklahoma (the "Corporation"),

DOES HEREBY CERTIFY:

FIRST: The Corporation was incorporated on the 13th day of November, 1991, pursuant to the Oklahoma General Corporation Act.

SECOND: The Corporation owns all of the outstanding shares of the capital stock of SolArc, Inc., a corporation incorporated on April 15, 2004 pursuant to the General Corporation Law of the State of Delaware ("SolArc (Delaware)"), the provisions of which permit the merger of a corporation organized and existing under the laws of the State of Delaware with a corporation organized and existing under the laws of another state.

THIRD: The Corporation, by the unanimous written consent of the members of the Board of Directors dated May 4, 2004, filed with the minutes of the Corporation and attached hereto as Exhibit A, has determined to merge itself into said SolArc (Delaware).

FOURTH: The merger has been approved by all of the holders of a majority of the common stockholders and all of the Series A Preferred Stockholders by written consent dated May 4, 2004, filed with the minutes of the Corporation and attached hereto as Exhibit B.


FIFTH: SolArc (Delaware) survives the merger and may be served with process in the State of Oklahoma in any proceeding for enforcement of any obligation of the Corporation as well as for enforcement of any obligation of the surviving corporation arising from the merger, including any suit or proceeding to enforce the right of any stockholder as determined in appraisal proceedings pursuant to the provisions of section 1091 of Title 18, Oklahoma Statutes, and it does hereby irrevocably appoint the Secretary of State of Oklahoma as its agent to accept service of process in any such suit or other proceeding. The address to which a copy of such process shall be mailed by the Secretary of State of Oklahoma is 320 South Boston, Suite 600, Tulsa, Oklahoma 74103-3713 until the surviving corporation shall have hereafter designated in writing to the said Secretary of State a different address for such purpose. Service of such process may be made by personally delivering to and leaving with the Secretary of State of Oklahoma duplicate copies of such process, one of which copies the Secretary of State of Oklahoma shall forthwith send by certified mail to the Corporation at the above address.
