TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of July 21, 2011, by MADISON CAPITAL FUNDING LLC, as agent ("Agent"). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Assignment (as defined below).

W I T N E S S E T H:

WHEREAS, REBOUND PHYSICAL THERAPY CENTER P.C., an Illinois professional corporation (the "Grantor") and Agent are parties to a Trademark Security Agreement dated as of December 30, 2010 (as amended, restated, supplemented or otherwise modified from time to time, the "Assignment"), pursuant to which Grantor mistakenly granted a security interest to Agent in certain trademarks ("Trademarks") and Trademark Rights (as defined below) as security for certain obligations owing by Grantor to Agent, including the Trademarks set forth on Schedule 1 hereto; and

WHEREAS, the Assignment was recorded by the Trademark Division of the United States Patent and Trademark Office on December 30, 2010, at Reel 4442, Frame 0782; and

WHEREAS, Grantor and Agent acknowledge and agree that Grantor is not the record owner of the Trademarks set forth on Schedule 1 hereto;

WHEREAS, Agent acknowledges that a valid security interest was not granted by Grantor to Agent with respect to the Trademarks set forth on Schedule 1;

WHEREAS, Agent desires to release its security interest in the Trademarks and Trademark Rights and reassign the same to the record owner of such Trademarks and Trademark Rights (the "Record Owner").

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Agent hereby releases any security interest it may hold in all of Record Owner's right, title and interest in and to the following (collectively the "Trademark Rights"):

(i) each Trademark listed on Schedule 1 annexed hereto, together with any reissues, continuations or extensions thereof, and all of the goodwill of the business connected with the use of, and symbolized by, each Trademark; and

(ii) all products and proceeds of the foregoing, including without limitation, any claims by Record Owner against third parties for past, present or


future (a) infringement or dilution of any Trademark, or (b) injury to the goodwill associated with any Trademark.

2. Agent hereby reassigns, grants and conveys to Record Owner, without any representation, recourse or undertaking by Agent, all of Agent's right, title and interest in and to the Trademarks and the Trademark Rights.
