RELEASE OF TRADEMARK SECURITY AGREEMENT

WHEREAS, pursuant to that certain Trademark Security Agreement, dated as of September 11, 2009 (the "Trademark Security Agreement"), The Specialized Packaging Group, Inc. and Specialized Packaging Radisson LLC ("Releasees"), granted to A3 Funding LP, in its capacity as agent for the Lenders ("Releasor"), a continuing first priority security interest in all of such Releasee's right, title and interest in, to and under the following, whether then existing or thereafter created or acquired (collectively, the "Trademark Collateral"): (i) all of such Releasee's trademarks, trademark applications, service marks, trade names and associated goodwill (collectively, "Trademarks"), and licenses for any of the foregoing ("Licenses"), including those U.S. trademarks and U.S. trademark applications referred to on Schedule A hereto; and (ii) all proceeds of the foregoing, including any claim by such Releasee against third parties for past, present or future infringement or dilution of any Trademark or any Trademark licensed under any License; and

WHEREAS, Releasees have requested and Releasor has agreed to provide this Release of Trademark Security Agreement to confirm the release, relinquishment and discharge of its continuing first priority security interest in the Trademark Collateral.

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, Releasor hereby agrees as follows:

1. Defined Terms. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

2. Release of Security Interest. Releasor hereby, without any representation and warrant and without any recourse to Releasor, releases, relinquishes and discharges its first priority continuing security interest in the Trademark Collateral.


