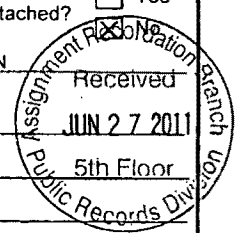

RELEASE OF SECURITY AGREEMENT

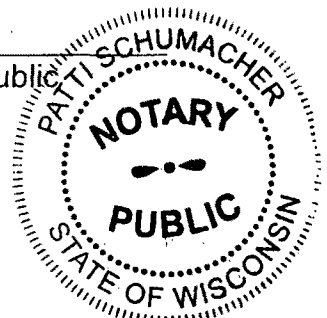
