THIS DEED is made the 28<sup>th</sup> day of October 2009

**BETWEEN:**

- (1) **GLAXOSMITHKLINE LLC** (formerly known as SmithKline Beecham Corporation of One Franklin Plaza, 200 N. 16<sup>th</sup> Street, Philadelphia PA 19102 USA) whose EIN number is 23-1099050 and whose registered office is at Corporation Service Company, 2711 Centerville Road, Suite 400, Wilmington, New Castle, Delaware 19808 USA (the “Assignor”); and
- (2) **VIIV HEALTHCARE COMPANY** (registered number 4672617) whose registered office is at Corporation Service Company, 2711 Centerville Road, Suite 400, Wilmington, New Castle, Delaware 19808 USA (the “Assignee”).

**WHEREAS:**

- (A) Each of the Assignor and the Assignee is a member of GSK's Group.
- (B) By a deed dated on or about 26 October 2009, Glaxo Group Limited assigned the GGL Marks to the Assignor. The Assignor's ownership of the GGL Marks has not yet been recorded at the relevant intellectual property registries.
- (C) By a deed dated on or about 26 October 2009, SmithKline Beecham p.l.c. (now known as SmithKline Beecham Limited) assigned the SBL Marks to the Assignor. The Assignor's ownership of the SBL Marks has not yet been recorded at the relevant intellectual property registries.
- (D) By a deed dated on or about 26 October 2009, Montrose Fine Chemical Company Limited assigned the Montrose Mark to the Assignor. The Assignor's ownership of the Montrose Mark has not yet been recorded at the relevant intellectual property registry.
- (E) Pursuant to the SPA, GSK has agreed to sell to Mercury the entire issued share capital in the Assignee and has agreed to procure that, prior to that sale, the Trade Marks are transferred to the Assignee.
- (F) In order to give effect to the GlaxoSmithKline Reorganisation, the Assignor has agreed to transfer to the Assignee the Trade Marks.

**NOW THIS DEED WITNESSETH** as follows:

**1. Interpretation**

1.1 In this Deed:

“GlaxoSmithKline Reorganisation” has the meaning given in the SPA;

“Group” has the meaning given in the SPA;

- “GGL Marks”** means the trade mark registrations and applications for registration listed in Part 2 of the Schedule;
- “GSK”** means GlaxoSmithKline plc (a company incorporated in England and Wales with registered number 03888792), whose registered office is at 980 Great West Road, Brentford, Middlesex TW8 9GS;
- “LLC Mark”** means the trade mark registration listed in Part 1 of the Schedule;
- “Mercury”** means ViiV Healthcare Limited (a company incorporated in England and Wales with registered number 06876960), whose registered office is at 980 Great West Road, Brentford, Middlesex TW8 9GS;
- “Montrose Mark”** means the trade mark registration listed in Part 4 of the Schedule;
- “SBL Marks”** the trade mark registrations and applications for registration listed in Part 3 of the Schedule;
- “SPA”** means the Agreement for the Sale and Purchase of the Share Capital of Pfizer-1, Pfizer UK Newco, Pfizer SPV, the Assignee and Mercury Healthcare UK (No. 2) Limited dated 16 April 2009 between Pfizer Inc., GSK and Mercury; and
- “Trade Marks”** means the LLC Mark, the GGL Marks, the SBL Marks and the Montrose Mark.

1.2 In this Deed, unless otherwise specified, references to Clauses and Schedules are to clauses of and schedules to this Deed and headings to Clauses and Schedules are for convenience only and do not affect the interpretation of this Deed.

## 2. Assignment

2.1 The Assignor does hereby assign unto the Assignee, and the Assignee hereby accepts, all the Assignor's right, title and interest in and to the Trade Marks together with all goodwill of the business in relation to which such Trade Marks are used (but no other or greater goodwill) to hold unto the Assignee absolutely.

2.2 The assignment made pursuant to Clause 2.1 includes all rights, privileges and advantages attaching to the Trade Marks, including, without limitation, the portion of Assignor's business to which those Trade Marks pertain and the right to take proceedings and recover damages and obtain all other remedies in respect of past infringements thereof.

**3. No Warranties**

Without prejudice to the terms of the SPA, the Assignee acknowledges that the Assignor does not give any representation, warranty, indemnity or guarantee under this Deed in respect of any of the Trade Marks.

**4. Further Assurance**

The Assignor shall, at the request and cost of the Assignee, execute any further documents that may be necessary to secure the vesting in the Assignee of all rights assigned to the Assignee hereunder.

**5. Counterparts**

This Deed may be executed in any number of counterparts, and by the Assignor and the Assignee on separate counterparts, but shall not be effective until each party has executed at least one counterpart. Each counterpart shall constitute an original of this Deed, but the counterparts shall together constitute but one and the same instrument.

**6. Governing Law and Jurisdiction**

6.1 This Deed shall be governed by and construed in accordance with English law. Any matter, claim or dispute arising out of or in connection with this Deed, whether contractual or non-contractual, is to be governed by and determined in accordance with English law.

6.2 The courts of England are to have jurisdiction to settle any matter, claim or dispute arising out of or in connection with this Deed and the parties hereby submit to the jurisdiction of the English courts. Each party waives (and agrees not to raise) any objection, on the ground of *forum non conveniens* or on any other ground, to the taking of proceedings in relation to any such matter, claim or dispute in the courts of England.





