## TRADEMARK AND KNOW-HOW ASSIGNMENT

This Trademark and Know-How Assignment (this "**Assignment**") is made and entered into by and between **Houbigant Inc.**, a Delaware corporation, and **Etablissement Houbigant**, a Liechtenstein corporation (collectively, the "**Assignor**"), and **IMG Fragrance Brands LLC**, a Delaware corporation (the "**Assignee**"). Capitalized terms used herein but not defined shall have the meaning(s) ascribed to them in the License Agreement (defined below).

### WITNESSETH

**WHEREAS**, Assignor and Assignee entered into a certain License Agreement dated December 19, 2003 (the "**License Agreement**") pursuant to which, among other things, Assignor licensed certain "Trademarks" and "Know-How" (as those terms are defined in the License Agreement) to Assignee;

**WHEREAS**, the License Agreement contains a Schedule A and a Schedule B, copies of which are attached hereto ("**Schedules A and B**");

**WHEREAS**, with respect to the Trademarks and the Know-How, to the best of Assignor's knowledge, but having undertaken no additional investigation and being unaware whether Assignee has taken or has failed to take any action that could affect such registration, Assignor is the registrant of the trademarks, trademark applications and know-how listed in Schedules A and B, along with other rights relating thereto and arising therefrom;

**WHEREAS**, subject to the recital above, Schedules A and B includes all of Assignor's worldwide trademark rights to the marks Chantilly, White Chantilly, Demi-Jour, English Waterlillies, Monsieur Musk, Bistro De Chantilly, Parfums Parquet, and French Vanilla;

**WHEREAS**, in accordance with the foregoing, Assignor is hereby irrevocably assigning to Assignee all of its right, title and interest in the Trademarks and Know-How, including but not limited to, the Trademarks and Know-How identified in Schedules A and B;

**NOW THEREFORE**, in consideration of the promises contained in that certain Confidential Settlement Agreement and General Release dated February \_\_, 2011 (the "**Settlement Agreement**") and other good and valuable consideration, the receipt of which is hereby acknowledged, the parties hereto agree as follows:

1. Assignor hereby assigns, conveys, grants sells and transfers to Assignee, its successors and assigns, all its entire worldwide right, title and interest in and to said Trademarks and Know-How, including but not limited to: (i) all registration rights with respect to the Trademarks and Know-How; (ii) all common law rights in, to and under the Trademarks and the Know-How; (iii) all rights to prepare derivative marks; (iv) any goodwill associated with the Trademarks and Know-How; (v) all income, royalties or claims (the latter of which is only to the extent not inconsistent with the Settlement Agreement) relating to the Trademarks and Know-How, due or payable on or after the date of this Assignment; (vi) the right to sue for any past infringement or misappropriation of any Trademarks and Know-How, including the right to

recover damages, lost income and/or royalties for past infringement or misappropriation of the Trademarks and Know-How.

2. Assignor hereby represents and warrants to Assignee that it has all authority necessary to enter into this Assignment; that, subject to the Third Recital above, it is the registered owner of the Trademarks and Know-How; that the Trademarks and Know-How are free and clear of all claims, liens and encumbrances of any kind; and that it has not taken any affirmative steps to diminish the value or validity of the Trademarks. For the avoidance of doubt, the Parties agree that the prosecution and defense of claims in the legal action formerly between them (S.D.N.Y. 09 Civ. 3655 (LAP)) shall not be deemed to constitute such affirmative steps. Assignor further represents and warrants to Assignee that, to the best of Assignor's knowledge:

- (a) there are no subsisting or other outstanding licenses to any third party relating to the Trademarks or the Know-How;
- (b) the Trademarks and Know-How do not infringe on the right of any person or entity and Assignor has not receive notice (of any kind) from a third party challenging Assignor's right to the Trademarks or Know-How (other than Assignee);
- (c) no person or entity (other than Assignee or its affiliates) has claimed ownership of the Trademarks or claimed that the Trademarks infringe any rights of any person or entity for the past three years (other than Assignee); and
- (d) none of the Trademarks are subject to any outstanding order, decree, judgment, office action (at the U.S. Patent and Trademark Office or elsewhere), stipulation or agreement limiting the scope or the use of any of the Trademarks.

3. For a two-year period commencing on the date hereof, Assignor agrees to assist Assignee, upon Assignee's reasonable request, by taking any reasonable action that may be necessary for the perfecting, securing and completing of assignment of all of the Trademarks and Know-How to Assignee. Assignee agrees to promptly either change any registrations of the Trademarks and Know-How in order to accomplish the foregoing or to abandon same. Assignee agrees to indemnify Assignor for any liability, claims and expenses (including legal fees and disbursements) for any loss suffered by Assignor as a result of being the registrant of the Trademarks and Know-How from the date hereof until the date Assignee changes such registrations, unless such liability, claim or expense relates to a time period before the date of this Agreement. In connection with the provisions in this Section 3, Assignor shall not be required to incur any costs (other than *de minimis* costs such as postage). Assignor hereby grants to Assignee a limited power of attorney, coupled with an interest, and irrevocably appoints Assignee and its successors and assigns as Assignor's true and lawful agent and attorney-in-fact to execute in the name and on behalf of Assignor any and all assignments, other documents and

instruments as Assignee may reasonably deem necessary or appropriate to further confirm and perfect, secure and complete the transfer to Assignee and registration and vesting of Assignee's ownership in and to any and all of the Trademarks and Know-How.

4. The covenants of Assignor contained in this Assignment shall apply to and bind the parties and their heirs, legal representatives, successors and permitted assigns.


