ACKNOWLEDGEMENT OF TRADEMARK ASSIGNMENT

This ACKNOWLEDGEMENT OF TRADEMARK ASSIGNMENT is effective as of the 15th day of November, 2006 ("Effective Date"), by and between Integra CI, Inc., a company organized under the laws of the Cayman Islands, referred to herein as "ASSIGNOR," and Integra LifeSciences NR Ireland Limited, a limited liability company formed under the laws of Ireland, referred to herein as "ASSIGNEE."

NOW, THEREFORE, for the sum of U.S. \$100 and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, effective as of the Effective Date ASSIGNOR hereby sells, assigns, and transfers to ASSIGNEE the entire right, title, and interest in and to said TRADEMARKS and the goodwill of the company symbolized by the TRADEMARKS, including the right to file foreign applications directly in the name of the ASSIGNEE and to claim for any such foreign applications any priority rights to which such applications are entitled under international conventions, treaties, or otherwise, and sells, assigns, transfers, and sets over to ASSIGNEE all income, royalties, damages, or payments due or payable as of the Effective Date or thereafter, including, without limitation, all claims for damages by reason of past, present, or future infringement or other unauthorized use of the TRADEMARKS, with the right to sue for, and collect the same for its own use and enjoyment, and for the use and enjoyment of its successors, assigns, or other legal representatives.

ACKNOWLEDGEMENT OF TRADEMARK ASSIGNMENT

Further, ASSIGNOR agrees that, upon request and without further compensation, but at no expense to ASSIGNOR, it and its legal representatives and assigns will do all lawful acts, including the execution of papers and the giving of testimony, that may be necessary or desirable for obtaining, maintaining, renewing, sustaining, or enforcing the TRADEMARKS in the United States and throughout the world, and for perfecting, recording, and maintaining the title of ASSIGNEE, its successors and assigns, to said TRADEMARKS in the United States and throughout the world.


ASSIGNOR represents and warrants that it has not granted and will not grant to any other or others any rights inconsistent with the rights granted herein.


