ASSIGNMENT OF TRADEMARK APPLICATION

Assignor is also assigning to Assignee the goodwill related to the Trademark Application and business.

2. **Consideration.** The consideration for the assignment of the Trademark Application and goodwill associated therewith is set forth in the APA and incorporated herein.


3. **Representations and Warranties of Assignor.** Assignor and Assignee hereby incorporate herein all representations and warranties set forth in the APA.




