## TRADEMARK RELEASE OF SECURITY INTEREST

THIS TRADEMARK RELEASE OF SECURITY INTEREST (the "Release") is made as of July 26, 2011 by BANK OF SCOTLAND PLC (FORMERLY THE GOVERNOR AND COMPANY OF THE BANK OF SCOTLAND), ("Security Agent").

### WITNESSETH:

WHEREAS, Security Agent and Environmental Resources Management-Southeast, Inc., a Delaware corporation ("Pledgor"), were parties to that certain Security Agreement, dated as of December 8, 2005 (as amended, restated, supplemented, or otherwise modified from time to time, the "Security Agreement"; capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed thereto in the Security Agreement), and an IP Supplement, pursuant to which Pledgor granted a security interest to Security Agent in, among other things, the Trademarks (as defined in the Security Agreement), as security for certain obligations owing by Pledgor, to the financial institutions (collectively, "Lenders") from time to time party to that certain Credit Agreement, dated as of October 28, 2005, by and among Pledgor, certain of Pledgor's affiliates, Security Agent and Lenders, as amended, restated, supplemented or otherwise modified and in effect from time to time, including the Trademarks set forth on Schedule 1 hereto; and

WHEREAS, the IP Supplement was recorded by the Trademark Division of the United States Patent and Trademark Office ("USPTO") on December 9, 2005 at Reel 3207 Frame 0211; and

WHEREAS, Pledgor has requested that Security Agent release its security interest in the Trademarks and reassign the same to Pledgor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Security Agent hereby terminates and releases all of its rights, title and interest in and to any of the Trademarks, now owned or at any time hereafter acquired by Pledgor, including its security interest in all of Pledgor's right, title and interest in and to all of the Trademarks (including any rights in and to any of the goodwill of the business connected with the use of, and symbolized by, each Trademark and any proceeds related to the foregoing, including without limitation any claim against third parties for past, present or future (i) infringement of any Trademark, or (ii) injury to the goodwill associated with any Trademark).

2. Security Agent hereby reassigns, grants and conveys to Pledgor, without any representation, warranty, recourse or undertaking by Security Agent, all of Security

Agent's right, title and interest in and to the Trademarks, and the goodwill of Pledgor's business connected with the use of and symbolized by the Trademarks.

3. Pledgor, or its designee, may record this Release in the USPTO and in any other offices as may be necessary to carry out the intention of this Release and, to the extent applicable, the parties hereto authorize and request that the USPTO record this Release.

4. Security Agent agrees to timely execute and deliver such other documents, and take all actions, as may be reasonably requested and prepared (as applicable) by the Pledgor, or its designee, to carry out and consummate this Release.
