GRANT OF A SECURITY INTEREST -- TRADEMARKS

WHEREAS, Action Automation & Controls, Inc., a Massachusetts corporation (the "Grantor"), holds all right, title and interest in the trademark listed on the attached Schedule A, which trademark issued in the United States Patent and Trademark Office (the "Trademark");

WHEREAS, the Grantor has entered into an Amended and Restated Security Agreement, dated as of July 29, 2011 (as amended, restated, supplemented, modified or otherwise changed from time to time, the "Security Agreement"), in favor of TriState Capital Bank, a Pennsylvania state chartered bank, as Agent (the "Grantee"); and

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantor does hereby grant to the Grantee a continuing security interest in the Collateral to secure the prompt payment in full when due, whether at stated maturity, by required prepayment, declaration, acceleration, demand or otherwise, all Secured Obligations.

The Grantor does hereby further acknowledge and affirm that the rights and remedies of the Grantee with respect to the Collateral are more fully set forth in the Security Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein.
