RELEASE OF SECURITY AGREEMENT

THIS RELEASE dated as of **May 23, 2011** (this "Release") is made by U.S. Bank National Association, a National Association, acting in its capacity as secured party (in such capacity, the "Secured Party") under that certain **Trademark Collateral Agreement**, dated as of **March 10, 2010** and recorded **Reel/Frame 004167/0494** in the records of the United States Patent and Trademark Office (as amended, supplemented or modified and in effect from time to time, the "Security Agreement"), among **Backyard Productions, Inc.**, (the "Debtor") and the Secured Party;

W I T N E S S E T H:

Intellectual Property Collateral including those set forth, and discharges, quit claims and relinquishes unto **Backyard Productions, Inc.**, (in each case without recourse and without any representation or warranty) any and all rights, title and interest it has in and the security interest granted to Secured Party in the Intellectual Property Collateral.
