## **RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (the “Release”) is given as of August 1, 2011, by Wilmington Trust, National Association (successor by merger to Wilmington Trust FSB), as collateral agent (the “Assignor”), in favor of MTR Gaming Group, Inc., a Delaware corporation (“MTR”), located at State Route 2 South, P.O. **NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assignor hereby releases all its rights in and to the Released Collateral and conveys to MPI and MTR, respectively as the Assignee identified in Exhibit A for the respective marks all of the Assignor’s right, title and interest in and to the Released Collateral, all without warranty or representation of any kind.
