**RELEASE OF
TRADEMARK SECURITY AGREEMENTS**

RELEASE OF TRADEMARK SECURITY AGREEMENTS, dated as of August 1, 2011, by **GENERAL ELECTRIC CAPITAL CORPORATION**, as Collateral Agent (as defined below) for the benefit of the Secured Parties (as defined below) in connection with the Third Amended and Restated Credit and Guaranty Agreement, dated as of March 5, 2010 (as amended, amended and restated, supplemented or otherwise modified and in effect from time to time, the "Credit Agreement") by and among EP MANAGEMENT CORPORATION, a Delaware corporation (f/k/a EaglePicher Corporation) (the "Borrower"), EPMC HOLDCO LLC, a Delaware limited liability company ("Holdco"), CERTAIN SUBSIDIARIES OF HOLDCO AND THE BORROWER (the "Guarantors"), the LENDERS PARTY THERETO FROM TIME TO TIME (the "Lenders") and GENERAL ELECTRIC CAPITAL CORPORATION, as Administrative Agent (together with its permitted successors in such capacity, the "Administrative Agent") and as Collateral Agent (together with its permitted successor in such capacity, the "Collateral Agent"). Capitalized terms used herein without definition shall have the meanings ascribed to such terms in the Credit Agreement.

WHEREAS, each grantor thereunder (collectively, the "2006 Grantors") and the Collateral Agent entered into that certain Trademark Security Agreement dated as of July 31, 2006 (the "2006 Trademark Security Agreement"), which 2006 Trademark Security Agreement was recorded with the United States Patent and Trademark Office at Reel 3363, Frame 0473 on August 7, 2006, for the purpose of securing the full, prompt and complete payment and performance of the Secured Obligations (as defined in the 2006 Trademark Security Agreement); and

WHEREAS, each grantor thereunder (collectively, the "2007 Grantors" and together with the 2006 Grantors, collectively, the "Grantors") and the Collateral Agent entered into that certain Amended and Restated Trademark Security Agreement dated as of December 31, 2007 (the "2007 Trademark Security Agreement" and together with the 2006 Trademark Security Agreement, collectively, the "Trademark Security Agreements"), which 2007 Trademark Security Agreement was recorded with the United States Patent and Trademark Office at Reel 003748, Frame 0918 on March 28, 2008, for the purpose of securing the full, prompt and complete payment and performance of the Secured Obligations (as defined in the 2007 Trademark Security Agreement); and

WHEREAS, pursuant to the Trademark Security Agreements, the Grantors granted, assigned and pledged to the Collateral Agent, for the benefit of the Secured Parties, by way of collateral security, all of the Trademark Collateral (as defined in each Trademark Security Agreement, respectively) as security for the full, prompt and complete payment and performance of the Secured Obligations (as defined in each Trademark Security Agreement, respectively).

The Collateral Agent, on behalf of the Secured Parties and in connection with the termination of the Credit Agreement and the satisfaction of the obligations thereunder, has agreed (i) to terminate and release its security interest and its right, title and interest in, to and under the Trademark Collateral including, without limitation, each Trademark (as defined in each Trademark Security Agreement, respectively) and Trademark License (as defined in each

Trademark Security Agreement, respectively) identified on Exhibit A attached hereto, all goodwill of the business connected with the use of, and symbolized by, such Trademarks and Trademark Licenses; and all Proceeds of the foregoing, including, without limitation, any claim by any Grantor against third parties for past, present or future (x) infringement or dilution of any Trademark or Trademark licensed under any Trademark License constituting Trademark Collateral including, without limitation, those identified on Exhibit A or (y) injury to the goodwill associated with any Trademark or any Trademark licensed under any Trademark License constituting Trademark Collateral including, without limitation, those identified on Exhibit A (collectively, the “Released Trademarks”) and (ii) to assign and transfer to each applicable Grantor all deeds, assignments and other instruments as may be necessary or proper to reassign, reconvey and re-vest in such Grantor the entire right, title and interest to the Released Trademarks as herein provided.

For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent, on behalf of the Secured Parties, hereby releases the Grantors from each Trademark Security Agreement and assigns and transfers to the Grantors, without representation, warranty or recourse, all of the Collateral Agent’s right, title and interest in and to each of the Released Trademarks, effective as of the date set forth above.
