## TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (the "**Assignment**") is made and entered into as of August 5, 2011, by and between Edge Oilfield Services Holding, L.L.C., a Louisiana limited liability company ("**Assignor**"), and Edge Oilfield Services, L.L.C., a Louisiana limited liability company ("**Assignee**").

WHEREAS, Assignor is the owner of a U.S. trademark application and Madrid Trademark Application listed in Exhibit A attached hereto and United States common law rights in the marks "CUTTING EDGE," "EDGE OILFIELD SERVICES," and "EDGE OILFIELD SERVICES & DESIGN" as set forth on Exhibit A attached hereto (all of the foregoing collectively referred to as the "**Trademarks**");

WHEREAS, Assignee is desirous of obtaining the Trademarks;

WHEREAS, Assignor and Assignee have entered into that certain Agreement and Plan of Merger dated July 13, 2011 by and among Assignor, Assignee and the other parties thereto (the "**Merger Agreement**"), pursuant to which Assignor has agreed to assign the Trademarks to Assignee;

NOW, THEREFORE, in consideration of the Merger Agreement, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor and Assignee agree as follows:

1. Assignor does hereby sell, assign and transfer to Assignee, and its successors and assigns, its entire right, title and interest in the Trademarks, together with the goodwill symbolized by said Trademarks, as well as any rights Assignor may have acquired by virtue of its use of the Trademarks, including any and all legal and equitable causes of action for any past, present or future infringement or unauthorized use of said Trademarks and the right to recover for all damages for such infringements, such Trademarks to be held and enjoyed by Assignee, its successors and assigns, as fully and entirely as the same would have been held and enjoyed by Assignor had this assignment and sale not been made;

2. Assignor covenants that it will provide commercially reasonable assistance to Assignee in making, executing, recording, and delivering all application papers and assignment or related instruments, and shall, upon request by Assignee and at Assignee's sole cost and expense, perform or cause to be performed such other lawful acts as Assignee may reasonably require to file for and prosecute the Trademarks.

3. This Assignment shall inure to the benefit of Assignee and its successors and assigns and shall be binding on Assignor and its successors and assigns.
