7. The merger shall be effective as of January 1, 2011.

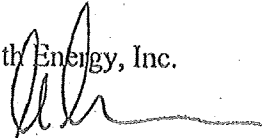
8. The merger is permitted by the jurisdiction of organization and is in compliance therewith with respect to the foreign constituent entity set forth in Item 3 above.
