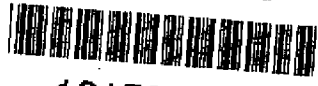


WHEREAS, the Assignee is desirous of releasing to the Assignor the Security Interests,


