Assignment of Trademark and Related Rights

RECITALS

WHEREAS,

 1. Obtaining United States Federal Trademark Registration No. 3,590,312, for SEMINOLE PARADISE covering shopping center services in International Class 36;



Warranty: Assignor hereby represents and warrants that Assignor has the full power, authority and right to assign the Intellectual Property as herein provided; that Assignor has not previously granted, conveyed, licensed, sold, transferred, or assigned to any other party any right, title or interest in or to the Intellectual Property, nor will Assignor hereafter do any of the foregoing.
- C. Assignment: This Assignment and all obligations and undertakings hereunder shall inure to the benefit of Assignor and Assignee and their respective employees, agents, successors, assigns, transferees, heirs and executors.


