TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of August 4, 2011 (“Release”), is made by CAPITALSOURCE CF LLC (“CapitalSource”) in favor of NEXT GENERATION VENDING AND FOOD SERVICE, INC., a Delaware corporation (the “Grantors”).

WHEREAS, Next Generation, certain of its affiliates and CapitalSource are parties to (i) a certain Second Amended and Restated Term Loan and Security Agreement dated as of November 25, 2008, and (ii) a certain First Lien Revolving Credit, Term Loan and Security Agreement dated as of November 25, 2008 (as each may be amended or otherwise modified from time to time, individually and collectively, the “Credit Agreement”) providing for extensions of credit to be made to Next Generation and certain of its affiliates by CapitalSource;

WHEREAS, pursuant to the Credit Agreement, CapitalSource and Next Generation entered into the Trademark Security Agreement dated as of December 29, 2008 (“Trademark Security Agreement”), and under the Credit Agreement and Trademark Security Agreement, Next Generation granted to CapitalSource a Lien upon all right, title and interest of Next Generation in, to and under all now owned and hereafter acquired right, title and interest in and to Trademarks and Trademark Collateral to secure the payment of all amounts owing by Next Generation under the Credit Agreement; and

WHEREAS, the Trademark Security Agreement was recorded at the United States Patent and Trademark Office (“USPTO”) on December 30, 2008 at Reel 3910 Frame 0857.

NOW THEREFORE, in consideration of the mutual promises and undertakings set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intention of being legally bound hereby, CapitalSource and Next Generation agree as follows:

SECTION 1. Defined Terms. All terms capitalized but not otherwise defined herein shall have the same meanings herein as in the Credit Agreement or Security Agreement.

SECTION 2. Termination and Release. CapitalSource hereby:

(a) terminates the Trademark Security Agreement and any other agreement under which Next Generation has granted a collateral mortgage, pledge, hypothecation, grant, assignment, lien, or security interest in, to, and under the Trademarks or Trademark Collateral, but only with respect to the Trademarks and Trademark Collateral listed on Schedule A attached hereto;

(b) cancels, discharges, and releases its Lien on and security interest in and to the right, title, and interest in, to, and under the Trademarks and Trademark Collateral listed on Schedule A attached hereto; and

(c) authorizes the recordation of this Release with the USPTO.

IN WITNESS WHEREOF, CapitalSource has caused this Release to be duly executed as of the date first set forth above.
