**RELEASE OF SECURITY INTEREST IN
TRADEMARK COLLATERAL**

This RELEASE, dated as of August 5, 2011, is made by Bank of America, N.A., as Administrative Agent ("Administrative Agent"), in favor of eNom, Incorporated ("eNom") as follows:

Administrative Agent agrees to provide eNom with any information and additional authorization necessary to effect the release of Administrative Agent's security interest in the Trademark Collateral.
