Assignor agrees to execute and deliver at the request *and expense* of the Assignee, all papers, instruments, and assignments, and to perform any other reasonable acts the Assignee requires to vest all of Assignor's rights, title, and interest in and to MARKS in the Assignee and/or to provide evidence to support any of the foregoing in the event such evidence is deemed necessary by the Assignee, to the extent such evidence is in the possession or control of Assignor.


