RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this "Release") is made this 2nd day of August, 2011, by CIT CAPITAL USA, INC., in its capacity as collateral agent for certain lenders (in such capacity, "Secured Party").

WHEREAS, reference is made to a certain Intellectual Property Security Agreement dated November 13, 2008 (as amended, restated supplemented and/or modified to date, the "Intellectual Property Security Agreement"), by and between DELTA RIGGING AND TOOLS, INC., a successor by merger to KELLY WIRE ROPE, INC., a Texas corporation (the "Grantor") and Secured Party. Capitalized terms used herein and not otherwise defined shall have the meanings ascribed thereto in the Intellectual Property Security Agreement.

WHEREAS, in connection with the Intellectual Property Security Agreement, the Grantor granted Secured Party, for the benefit of the Lenders, a continuing security interest in all of the right, title and interest of Grantors in and to the trademark collateral identified therein (collectively, "Trademark Collateral").


