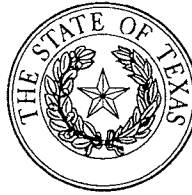

Pursuant to the provisions of Section 3.053 of the Texas Business Organizations Code (the "*Code*"), Desert Glory, Ltd., a Texas limited partnership (the "*Limited Partnership*"), has adopted the following Certificate of Amendment (the "*Amendment*") to the Limited Partnership's Certificate of Formation (the "*Certificate of Formation*"):

ARTICLE 1

The name of the Limited Partnership is Desert Glory, Ltd. The filing number issued to the Limited Partnership by the Secretary of State of the State of Texas is: 8673710. The Limited Partnership was formed on January 31, 1996.

ARTICLE 2
