RELEASE OF TRADEMARK SECURITY INTEREST

This RELEASE is made as of August 5, 2011 by SUNTRUST BANK, as Administrative Agent for the Lenders ("*Secured Party*").

WITNESSETH:

WHEREAS, Secured Party and FOGO DE CHÃO CHURRASCARIA (HOLDINGS) LLC, a Delaware limited liability company ("*Grantor*"), are parties to that certain Guaranty and Security Agreement, dated as of June 26, 2008 (the "*Security Agreement*"),

WHEREAS, in connection with the Security Agreement, Secured Party and Grantor are parties to that certain Grant of Security Interest – Patents and Trademarks, dated as of June 26, 2008 (the "*Trademark Security Agreement*"), pursuant to which Grantor granted a security interest to Secured Party in the Marks (as defined in the Trademark Security Agreement) set forth in Schedule I attached hereto and all goodwill of the business connected with the use of and symbolized by each Mark;

WHEREAS, Secured Party recorded the Trademark Security Agreement with the Assignment Division of the United States Patent and Trademark Office on July 3, 2008 at Reel 3809, Frame 0450; and

WHEREAS, Secured Party has agreed to release its rights under the Security Agreement and the Trademark Security Agreement and to reconvey to Grantor any and all rights in and to the Marks and all goodwill of the business connected with the use of and symbolized by each Mark.

NOW THEREFORE, in consideration for the premises and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. Secured Party hereby terminates, releases and discharges its security interest in the Marks originally granted to Secured Party pursuant to the Security Agreement and the Trademark Security Agreement and releases all other rights it may have to the Marks under the Security Agreement and the Trademark Security Agreement.
2. Secured Party, to the extent granted in the Security Agreement or the Trademark Security Agreement, hereby assigns, grants and otherwise re-conveys to Grantor, without any representation, recourse or undertaking by Secured Party, all of its right, title and interest in and to the Marks and all goodwill associated therewith originally granted to Secured Party pursuant to the Security Agreement or the Trademark Security Agreement.
3. Upon the request of Grantor, Secured Party, at the Grantor's expense, further agrees to execute all documents necessary to demonstrate and confirm the parties' intent under this Release of Trademark Security Interest.

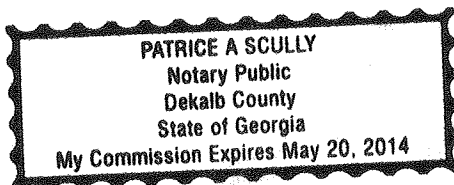



