
Gentlemen:

Please be advised that pursuant to that certain Trademark Security Agreement dated September 23, 2003, and recorded with the United States Patent and Trademark Office on September 29, 2003, Reel 002836, Frame 0531 (as at any time amended, the "**Trademark Security Agreement**"), by and between M. S. 
