RELEASE OF SECURITY INTEREST IN TRADEMARKS

WHEREAS, **BIOGENEX LABORATORIES**, a California corporation with a principal office at 4600 North Canyon Road, San Ramon, California 94583 (“Grantor”), granted a security interest in and lien upon certain Trademarks and related rights to **OXFORD FINANCE LLC**, a Delaware limited liability company, as successor in interest to Oxford Financial Corporation, with a principal place of business at 133 North Fairfax Street, Alexandria, Virginia 22314 (“Secured Party”) as set forth in that certain Intellectual Property Security Agreement, dated May 5, 2005, by Grantor in favor of Secured Party (the “Security Agreement”);


NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Secured Party hereby:

2. agrees that any power of attorney or similar rights granted by Grantor to Secured Party pursuant to or in connection with the Security Agreement is terminated; and
3. authorizes and requests that the United States Patent and Trademark Office note and record the existence of the release hereby given.
