Playmates Toys International hereby sells, assigns, transfers and conveys to Playmates IP the entire right, title, interest in and to the Trademark in the United States and all jurisdictions outside the United States, together with the goodwill of the business connected with, and symbolized by, the Trademark (including, without limitation, the right to renew any registrations included in the Trademark, the right to apply for trademark registrations within or outside the United States based in whole or in part upon the Trademark, and any priority right that may arise from the Trademark), including all causes of action as may have accrued on or before the date of this Trademark Assignment, the same to be held and enjoyed by Playmates IP as fully and entirely as said interest could have been held and enjoyed by Playmates Toys International had this sale, assignment, transfer and conveyance not been made.

Playmates Toys International authorizes the Commissioner of Trademark of the United States and other empowered officials of the United States Patent and Trademark Office, and in any applicable jurisdictions outside the United States, to record the transfer of the registration for this Trademark to Playmates IP. Playmates Toys International agrees to further execute any documents reasonably necessary to effect this Assignment, or to confirm Playmates IP's ownership of the Trademark.
