WHEREAS, Releasee has requested and Releasor has agreed to provide this Release of Intellectual Property Security Agreement to terminate, release, relinquish and discharge any and all of its security interest in the Intellectual Property Collateral, including, without limitation, the Patents, Trademarks and Copyrights set forth on Schedules A, B and C, respectively, attached hereto.

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, the Releasor hereby agrees as follows:


1. Defined Terms. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Recorded Security Agreements.
