TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**, dated as of August 11, 2011 ("Release"), is made by CAPITALSOURCE FINANCE LLC ("CapitalSource") in favor of NEUVILLE INDUSTRIES, INC., a North Carolina corporation and INTERNATIONAL LEGWEAR GROUP, INC., a Virginia Corporation (each a "Grantor" and collectively, the "Grantors").

WHEREAS, the Grantors and CapitalSource (as the assignee of Bank of America, N.A.) are parties to that certain Loan and Security Agreement, dated as of April 4, 2005 (as amended, supplemented or otherwise modified from time to time, the "Loan Agreement"), and in connection with the Loan Agreement, Neuville Industries, Inc. entered into that certain Trademark Security Agreement dated as of April 4, 2005, as amended by that certain First Amendment to Trademark Security Agreement dated as of August 29, 2006, as assigned to CapitalSource pursuant to that certain Amendment and Assignment of Trademark Security Interest, dated as of October 25, 2006 (the "Trademark Security Agreement"), and pursuant to the Loan Agreement and Trademark Security Agreement, Neuville Industries, Inc. granted to CapitalSource a Lien upon all right, title and interest of in, to and under all now owned and hereafter acquired right, title and interest in and to Trademarks and Trademark Collateral to secure the payment of all amounts owing by Grantors under the Loan Agreement; and

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on (i) April 5, 2005, at Reel 003083, Frame 0179, (ii) August 31, 2006, at Reel 3382, Frame 0132 and (iii) July 5, 2007 at Reel 003575, Frame 0106;

WHEREAS, the Grantors and CapitalSource are parties to that certain Revolving Credit, Term Loan and Security Agreement, dated as of January 13, 2003 (as amended, supplemented or otherwise modified from time to time, the "Loan Agreement"), and in connection with the Loan Agreement, the Grantors entered into that certain Intellectual Property Security Agreement dated as of the January 13, 2003, as amended by that certain First Amendment to Intellectual Property Security Agreement and Joinder dated June 7, 2004, as amended that certain Second Amendment to Intellectual Property Security Agreement dated as of April 4, 2005, and as amended by that that certain Third Amendment to Intellectual Property Security Agreement dated as of May 5, 2006 (the "IP Security Agreement") whereby the Grantors granted to CapitalSource, a security interest in certain Intellectual Property;

WHEREAS, the trademarks assigned in the IP Security Agreement were recorded with the United States Patent and Trademark Office on (i) April 24, 2006, at Reel 003295, Frame 0032, (ii) June 25, 2004, at Reel 003000, Frame 0542, and (iii) May 19, 2006, at Reel 003312, Frame 0678;

WHEREAS, patent number 5004132 was assigned in the IP Security Agreement and was recorded with the United States Patent and Trademark Office on (i) April 24, 2006, at Reel 017507, Frame 0747, and (ii) May 19, 2006, at Reel 017636, Reel 0644;

WHEREAS, patent number 6308337 was assigned in the IP Security Agreement and was recorded with the United States Patent and Trademark Office on (i) January 22, 2003, at Reel

013663, Frame 0324, (ii) April 24, 2006, at Reel 017507, Reel 0474; and (iii) May 19, 2006, at Reel 017636, Frame 0644.

NOW THEREFORE, in consideration of the mutual promises and undertakings set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intention of being legally bound hereby, CapitalSource and Grantor agree as follows:

SECTION 1. Defined Terms. All terms capitalized but not otherwise defined herein shall have the same meanings herein as in the applicable Loan Agreement, the Trademark Security Agreement or IP Security Agreement.

SECTION 2. Termination and Release. CapitalSource hereby:

(a) terminates the Trademark Security Agreement, the IP Security Agreement and any other agreement under which Grantors have granted a collateral mortgage, pledge, hypothecation, grant, assignment, lien, or security interest in, to, and under the Trademarks, Trademark Collateral and Intellectual Property listed on Schedule A and Schedule B attached hereto;


(b) cancels, discharges, and releases its Lien on and security interest in and to the right, title, and interest in, to, and under the Trademarks, Trademark Collateral and Intellectual Property listed on Schedule A and Schedule B attached hereto;

(c) to the extent CapitalSource retains any interest in the Trademarks, Trademark Collateral or Intellectual Property, it hereby assigns to Grantors, all right, title and interest CapitalSource may have, if any, in the aforesaid Trademarks, Trademark Collateral or Intellectual Property; and

(d) authorizes the recordation of this Release with the United States Patent and Trademark Office.
