On January 25, 2002, TECSYS DEVELOPMENT, INC, now known as TDI TECHNOLOGIES, INC (TDi") entered into a Security Agreement with THE FROST NATIONAL BANK ("Frost") contemporaneously with, and as a condition of, a certain Loan Agreement.
