
TRADEMARK ASSIGNMENT



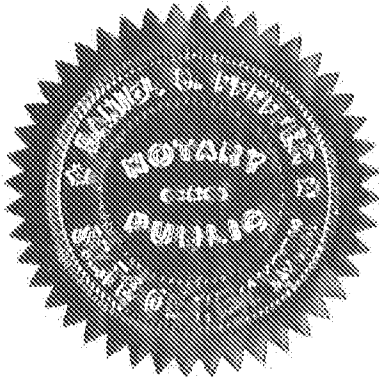
