**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

**THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this "Release") is made as of July 29, 2011 granted by Bank of America, N.A., in its capacity as administrative agent pursuant to that certain Credit Agreement dated as of December 14, 2010 (as amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement") among Vonage America Inc., a Delaware corporation, Vonage Holdings Corp., a Delaware corporation, the lenders and other parties thereto from time to time and Bank of America, N.A., as Administrative Agent (in such capacity, the "Administrative Agent") (capitalized terms used herein have the meanings attributed thereto in the Credit Agreement unless otherwise defined herein) in favor of Vonage Marketing LLC (the "Grantor").

**WHEREAS**, pursuant to the terms and conditions of that certain Trademark Security Agreement dated as of December 14, 2010, among the Grantor and the Administrative Agent (as amended, supplemented or otherwise modified, the "Trademark Security Agreement"), the Grantor pledged to the Administrative Agent a continuing security interest in all of its right, title and interest in certain Collateral including, without limitation, the trademark registrations and applications set forth on Schedule I hereto together with the goodwill associated therewith (collectively, the "Trademarks"); and

**WHEREAS** the Trademark Security Agreement has been recorded with the Trademarks Division of the U.S. Patent and Trademark Office on December 16, 2010 at Reel 004432 and Frame 0333;

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Administrative Agent hereby terminates the Trademark Security Agreement and the Security Agreement insofar as it relates to the Trademarks, and hereby terminates, cancels, re-pledges, reassigns and releases any and all security interests it has against the Trademarks, together with the goodwill associated with such Trademarks, and all Proceeds (as defined in the Security Agreement) of any and all of the foregoing, without warranty or recourse.

If and to the extent the Administrative Agent has acquired any right, title or interest to any of the Trademarks, it hereby assigns and transfers such rights, title or interest to the Grantor.

The Administrative Agent shall take all further actions, and provide to the Grantor and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantor to more fully and effectively effectuate the purposes of this Release.

This Release shall be construed in accordance with and governed by the law of the State of New York.
